# Putting Mountains on the Global Agenda: UN Declares 2002 as the Year of Mountains

The focus during the International Year of Mountains (IYM) will be the well being of mountain and lowland communities through promoting the conservation and sustainable development of mountain regions. FAO, the UN's lead agency for IYM, is working closely with other organisations to ensure that a wide range of expertise is focused on sustainable mountain development.

The United Nations General Assembly, at its 53rd session. adopted resolution 53/24 proclaiming 2002 the International Year of Mountains (IYM). The resolution encouraged all governments, the United Nations agencies and all other actors to take advantage of the IYM in order to increase awareness of the importance of sustainable mountain development. It also called upon governments, national and international organisations, nongovernment organisations and the private sector to make voluntary contributions in accordance with the guidelines of the Economic and Social Council for International Years and Anniversaries and to lend other forms of support to the IYM.

In 1992, the United Nations Conference on Environment and Development, known as the Rio Conference, adopted Agenda 21. Chapter 13 of this is the 'Mountain Agenda' (Managing Fragile Ecosystems: Sustainable Mountain Development) and centres on the issues of concern, including the need for an ecosytems' focus. In 2002 a decade of implementation of Agenda 21 will be evaluated in Johannesburg (September 11-19, 2002) and many IYM activities are closely linked to this global conference, often referred to as Rio plus 10.

FAO announced that by April 18th 2001, 17 countries had established IYM national committees: Armenia, Australia, Austria, Bolivia,

the Dominican Republic, France, Germany, Guinea, Italy, Kyrgyzstan, Liechtenstein, Madagascar, Morocco, Peru, Swaziland, Slovenia, and Tunisia. In 13 other countries, IYM national committees are being established. They include several of the HKH countries. ICIMOD is encouraging the establishment of national committees within the region and preparatory workshops have already taken place in Nepal, Myanmar, and Bhutan.

Twenty-one countries in Asia have confirmed to FAO that they will establish committees to celebrate IYM. The following HKH countries are establishing committees.

**Bhutan:** the focal point is the Ministry of Agriculture. Dasho Sangay Thinley is the Chairperson and Dr. Pema Gyamtsho, Member Secretary. The committee has 12 other representatives from other ministries and organisations.

**China:** the focal point is the Ministry of Agriculture of the People's Republic of China.

Myanmar: no focal point designated yet; the Forest Department, Ministry of Forestry, is the focal point for ICIMOD. Pakistan: the focal point is the Ministry of Environment, Local Government and Rural Development, Islamabad. Mr. Ismail Hassan Niazi, Joint Secretary, Ministry of Tourism and Sports, is the designated head of the committee.

**Nepal:** a high-level national committee has been established under the Ministry of Foreign Affairs, with the Ministry of Forests and Soil Conservation as the contact point.

National committees have not yet been established in Bangladesh, and India

up to assist other national committees with ideas for action in their own countries.

#### What are the issues?

Today there is increasing recognition of the importance of mountain ecosystems. On a global level, they are the water towers of the earth. The world's largest repositories of biological diversity are found in the mountains. Mountain areas are popular destinations for recreation and tourism. The importance of the cultural diversity and heritage found in the mountains cannot be measured in terms of mere economics. Yet, mountains are home for a disproportionate the world's poorest number of peoples. Mountains occupy about one-fourth of the world's land surface and are the basis of livelihood for 10% of the world's population. Crucial goods and services are provided by mountain areas to more than half the world's population. According to a report by the Secretary General of the UN to the 55th General Assembly on the Status of Preparations for IYM, ecological integrity economic and social viability of mountain areas need to be ensured, both for the sake of mountain inhabitants and for those living in lowland areas.

An international year dedicated to mountains is a unique opportunity to consolidate and capitalise on the many efforts carried out to date to protect and develop mountain regions. It also provides us with an opportunity to renew and intensify our commitment to our work in mountain areas, to celebrate the mountains and the communities that ensure their sound stewardship. But the real challenge lies in being able to focus on action-oriented activities aimed at long-term and sustained

efforts to improve the quality of life and environmental stability in the mountains. Concerted action is needed to build and strengthen the institutional and human capacity to continue with sustainable mountain development beyond 2002. Thus the IYM is meant to be much more than just a series of events and activities confined to a one-year period, rather it is a spring board from which to launch or reinforce long-term mountain development and conservation efforts. The IYM Coordination Unit in FAO allows the use of the IYM logo for all activities, as long as they are informed about them.

Some of the ideas for International Year of Mountains 2002 celebrations and beyond are as follow. **Local** 

At the local level, educational videos on local mountain culture, exhibitions, essay and painting competitions, mountain festivals, and food festivals can be organised.

National

Most national-level preparations are focused on conferences about issues of regional concern, policy-level forums, and celebrations. National Committees are also committed to taking stock of the past 10 years in terms of policy and implementation of programmes that have helped conserve mountain ecosystems. Several country-level preparations are also focused on creating greater

awareness in schools and educational institutions. Promoting eco-tourism and responsible management of the mountain environment are important issues being addressed.

#### Regional

To establish cooperative programmes on conservation and transboundary issues, several NGOs are planning regional events. Publishing thematic books, travelling exhibitions, stamp releases, regional conferences, transboundary cooperation programmes, are among the activities proposed.

#### Global

It is a year of celebration. ICIMOD and the Mountain Forum will take lead roles. One mega global event to be held will be the Mountain Women's Agenda meeting in May 2002. You can read

about it in this issue of the ICIMOD Newsletter.

The IYM has longer term implications for mountain countries such as Nepal. Nepal is a mountainous country with almost two-thirds of the land covered by mountains and hills, and the Nepal Himalayas contain the world's highest peak, Mt. Sagarmatha. These mountains are a great attraction for tourists from all over the world. Tourism is the backbone of the economy and one of the largest foreign currency earners. But with the growing numbers of climbers, garbage litters the base camps and the paths to the summits of the world's highest mountains. Although efforts are underway to clean these Himalayan peaks, it is difficult to keep ahead of the task.

Nepal's mountains are also the source of many of the great river systems of South Asia: among them Kali Gandaki Koshi and Mahakali. But the Himalayan environment is sometimes badly affected by human activities with deforestation and land degradation among the obvious signs. If the Himalayan environment and eco-system are not conserved, not only Nepal but the whole of South Asia will suffer. We must remember this and make efforts to reconcile such issues during IYM.

#### **Meeting of European National Committees**

An important meeting was convened at the European Parliament in Brussels on 19th June by the President of the Italian Committee for the IYM, Luciano Caveri, who is also a Member of the European Parliament. This meeting brought together representatives of the IYM national committees from Austria, France, Germany, Hungary, Italy, Slovakia, and Slovenia, as well as representatives from Kyrgyzstan and several European and international organizations working on IYM preparations. The purpose was to enhance coordination and collaboration and to promote the exchange of information and ideas regarding national and regional initiatives for IYM in Europe. Several members of the recently constituted "Friends of the Mountains" Group within the European Parliament also participated in the meeting. This group intends to continue to pay close attention to mountain themes up to, throughout, and beyond the IYM. Similar regional gatherings of IYM national committee representatives are strongly encouraged.

#### Meeting of the IY Focus Group

On Jine 11th, the IYM Focus Group held an important meeting at the Swiss Mission in New York. Eight countries, FAO, UN/DESA, and TMI were represented. During the meeting, Mr. Tim Aldington, recently appointed by FAO as the IYM Launch Coordinator working out of the FAO Liaison Office to the UN in New York, was introduced to the group. The main discussion focused on the structure and organisational aspects of both the formal IYM launch event, scheduled for 11 December 2001, and the related informal activities that will take place throughout the week.

# IYM 2002: What Is Going On, What Is Coming Up?

s the International Year of Mountains approaches, awareness grows about the potential of this global landmark and its possible impact on the evolving livelihood systems of mountain communities and their future. Despite the fact that they were once cradles of civilisation and are currently sites of rich and lively cultural heritage, and despite the key role they play in ecological processes, neglect for mountain regions has characterised the global community this past century.

A marginalised and protracted social and environmental reality is now given the opportunity to make the headlines and make itself known. Worldwide, governments with a stake in these regions, mountain communities, and institutions concerned with these varied environments and their wealth of cultural diversity, are organising themselves to celebrate IYM. The response of the global community to this UN call is already exceeding all expectations.

At present, nearly thirty countries IYM National have established Committees, most of them bringing together the public sector and the civil community. Committees have started organising a vast array of activities: from artistic performances and political gatherings, to platforms on which to offer mountain communities a more equitable access to world markets, and ceremonies to enhance the sacredness of ancient mountain deities. Rapid and regular review of the Mountain Forum's Calendar of Events reflects the dynamism of this process, a process that is currently going well beyond the initial expectations of those who promoted the concept. IYM is gaining momentum: from compensations for mountain services to lowlands to a comprehensive global mountain charter that will give these areas a more equitable stand in the forum of modern nations.

At the UN, a multi-country focus group brings together a leading team of nations committed to the significant success of IYM. Preparations for the official launching of IYM during the UN General Assembly on December 11th include addresses from the UN

Secretary General, FAO's Director General, and several Heads of State. Side events will bring together mountain scholars, community leaders, policymakers, artists, and other interested citizens from around the globe.

In preparation for IYM, many activities are currently taking place worldwide. During the last meeting of the UN Commission for Sustainable Development (April 2001), the Swiss Mission to the UN co-sponsored, along with eight other countries (Austria, Bhutan, Bolivia, Ethiopia, Guatemala, Kyrgyztan, Lao PDR, and Lesotho), a 'Sustainable Mountain Development' (April 17) side event. Among others, the FAO Unit for IYM and the Mountain Forum Secretariat made presentations. Shortly afterwards, the Peruvian

Committee for IYM organised an 'International Workshop of Mountain Sustainable Development: A Vision for the Future'. This meeting brought together a hundred and fifty participants from over 20 countries. The 'Cusco Declaration on Mountain Sustainable Development' was one of its outcomes.

Since last April, the FAO Unit for IYM has published an informal newsletter to bring people up to date on global activities for the coming year. Equally, the Mountain Forum has a constantly updated 'Calendar of Events' that can be seen at its website (www.mtnforum.org).



# ICIMOD Advocating for Marginal Regions and Marginalised Communities in the Hindu Kush-Himalayas

.n October 1997, the International Facilitating Committee of the Mountain Forum, which consisted of The International Potato Centre (CIP). The Mountain Institute (TMI), and ICIMOD met at ICIMOD Headquarters in Kathmandu. Khyrgiz participants at the meeting tabled the idea of lobbying the UN for an international year for mountains. In 1998, the Asia Pacific Mountain Network (APMN)/ICIMOD attended a meeting in Bishkek and at this meeting the lobby was devised. The lobby received enthusiastic support from many quarters and hence led to the declaration of IYM by the UN Secretary General.

ICIMOD is suited to and should take a leadership role during IYM 2002. Recognising the unique opportunity the IYM 2002 offers, ICIMOD has already begun processes of consultation, dialogue, and reflection with various stakeholder institutions in its eight member countries. Key issues and plans have already been identified.

ICIMOD's objective is to undertake specific interventions in the mountain areas of the HKH region to advocate for marginal regions and marginalised communities and to make significant contributions to the lives of the men and women of these areas.

IYM has also been proclaimed the International Year of Ecotourism. These twin themes are significant since ecotourism is a major source of employment and income contributing to transforming mountain areas. The growth of tourism globally and its accompanying impact on mountain areas and cultures offer yet another opportunity to deal with the dilemmas of conservation and development.



The way is steep without a helping hand

Certain opportunities are offered by the convergence of the International Year of the Mountains and the International Year of Ecotourism.

1. A unique opportunity to make a difference to the lives of mountain women and men by pursuing a diversity of programmes and interventions, designed by them, with them, and for them

2. An endorsement of ICIMOD's commitment to marginal areas and marginalised communities through the adoption of a year-long programmatic commitment regionally and/or globally

3. A vital opportunity to address key strategic issues that can lead to systemic and structural changes, the gains from which will accrue way beyond the year itself. Such strategic issues include property rights for women, access and rights to common property resources, interventions in the emergence of new policies and legislation, conflicts and peace in mountain regions, and the rights of ethnic and disadvantaged groups

4. A window through which to pursue rapid formulation and

emergence of appropriate and new mountain policies and legislation since the TYM year will be used to gain access to policy makers through various fora and discussions

5. An opportunity for advocacy and media coverage that will take advantage of the growth of electronic media to improve its ability to advocate and its reach, while also using mainstream media to publicise, address, and challenge stereotypes about mountain people and mountain issues

ICIMOD's preparations for IYM 2002 have included internal dialogue as well as discussions with selected partner organisations in the HKH. The consensus has been that the overarching focus of activities should be on marginal areas and marginalised communities in mountain areas. Thus ICIMOD is prioritising 'Marginal Regions and Communities' as a theme for IYM 2002. Some of the specific activities to be undertaken are described in the following pages.



# Integrating Culture and Sustainable Natural Resource Management Challenges in the Hindu Kush-Himalayas

he United **Nations** declaration of the year 2002 as the International Year of the Mountains (IYM) offers ICIMOD a unique opportunity to advocate for the cause of mountain people and mountain resources on behalf of its constituency of 150 million women and men in the eight countries of the Hindu Kush-Himalayas. The goal of IYM 2002 is to 'promote the conservation and sustainable development mountain regions, thereby ensuring the well-being of mountain and communities.' Other lowland objectives are increasing awareness of mountain ecosystems and their importance for both highland and lowland people, defending the cultural heritage of mountain and promoting communities, peace-making in mountain regions. These objectives are to be achieved methods such through information generation exchange, raising awareness, and education.

Recognising these opportunities, ICIMOD, the King Mahendra Trust for Nature Conservation (KMTNC), and The Mountain Institute (TMI) have agreed to create a tripartite consortium for a new regional initiative on mountain culture and natural resource management in the Hindu Kush-Himalayas. All three organisations are known for their commitment to mountain issues and mountain communities. collaborative initiative will build on the comparative strengths of each organisation to offer effective and durable outcomes.

- Undertaking research to produce a bibliography on culture and natural resource management in the Hindu Kush-Himalayas
- Designing and hosting policy level fora to identify interventions that could influence and imbue natural resource policy-making with more appreciation for cultural diversity in mountain regions
- Organising a series of national, sub-national and regional consultations with partner institutions to identify issues and activities for IYM 2002
- Hosting a focused electronic discussion to solicit inputs and ideas for a global audience in the planning phase for IYM 2002
- Establishing linkages and contacts with key mainstream media individuals and institutions and exploring a strategy to improve the media and advocacy impacts of IYM 2002 activities
- Enshrining a strong element of participatory planning for IYM 2002 by building ownership,

seeking relevance, and securing commitments from a diversity of organisations in the Hindu Kush-Himalayan region

The following outputs are expected from the planning phase.

- 1. A detailed proposal for implementation with an action plan and budget covering the preparatory phase and implementation of IYM 2002 activities on Culture and Natural Resource Management 2. A concept paper outlining the framework and operational definition of culture and the relationship to
- natural resource management 3. Consultation and workshop reports to be disseminated to participants, partners, and other interested groups
- 4. A bibliography that includes success stories
- 5. A media advocacy strategy document that will identify media partners and guide the implementation phase

# Regional Programme on Farmers' Rights to Livelihoods in the Hindu Kush-Himalayas

he natural and social capital the Hindu Kush-Himalayan region is facing new challenges from the complex market forces currently known as liberalisation and globalisation. While open economies and regions are likely to bring new opportunities to spur economic growth and development, these will not occur without accompanying negative aspects. The multilateral agreement on trade liberalisation tabled by the World Trade Organisation (WTO) will definitively impact on the HKH region.

Whatever limited resources mountain communities have at their disposal are being threatened corporations developed countries. There is already evidence of 'bio-piracy' and this is likely to increase due to the frightening provisions of the WTO's Trade Related Aspects of Intellectual Property Rights (TRIPS) Agreement. The patenting of life forms and the imperative to provide protection to varieties, either through patents or a home-grown (sui generis) system, further limit the rights of farming communities in developing countries, in general, and of small and marginalised mountain farmers in particular. In addition, other WTO agreements, such as the Agreement on Agriculture and Sanitary and Phyto-sanitary Measures and Technical Barriers to Trade, are also likely to pose a serious threat to mountain farmers.

In this context, the South Asia Watch on Trade, Economics, and Environment (SAWTEE), in cooperation with ICIMOD, will carry out a programme to protect the rights of farmers and marginalised communities of the Hindu Kush-Himalayan region. The programme will focus on raising the level of debate on issues of

protection and promotion of farmers' rights in the WTO at the level of civil society, national alliance institutions, and policy-makers. In addition, SAWTEE will carry out research on crucial issues and produce a series of clear and easily understandable documents on these issues that will be made available in regional languages as well as in English.

To protect the rights of farmers and marginalised communities the project will focus on the Hindu Kush-Himalayan region. Sri Lanka will also be included, however. Activities during the initial three-year phase will be concentrated in Bangladesh, India, Nepal, Pakistan, and Sri Lanka, with possible replication in other HKH countries. The project's main target group are poor, marginalised, and vulnerable farmers.

The programme has three distinct components.

- 1. Increasing awareness of parliamentarians and policy-makers about the impact of the WTO agreements on farmers in the HKH region
- 2. Regularly updating negotiators in WTO negotiations about the issues at stake that could have some bearing on mountain farmers

and communities

3. Using the leverage of the United Nations' declaration of the International Year of Mountains 2002 (IYM) to advocate for policy at national, regional, and international levels that will protect the rights of farmers in mountain regions

The project will also carry out review and analysis of international policies, rules, and regulations pertaining to the protection of farmers' rights.

Each SAWTEE country will have its own programme implemented by member organisations in the country. These are the Bangladesh Environment Lawyers Association (BELA) in Bangladesh; the Consumer Unity and Trust Society (CUTS) in India; the Forum for Protection of Public Interest (Pro Public) in Nepal; the Sustainable Development Policy Institute (SDPI) in Pakistan; and the Law and Society Trust (LST) in Sri Lanka. The overall project will be coordinated by the SAWTEE Secretariat in co-operation with ICIMOD.

On 12-13 July 2001, participating organisations gathered in Kathmandu for a workshop that formally launched the programme.

# Celebrating Mountain Women

ountain women often appear more independent and have traditionally been afforded more freedom of movement, independent decision-making, and higher status than women in the lowlands. However, instead of celebrating this higher status, and its benefits to the community at large, the social and economic integration of mountain areas into nation states is rapidly eroding their status. Unfortunately, women all over the world suffer from many common prejudices and mountain women are no exception.

Although mountain women are the main producers of food crops and managers of common property resources. there are impediments to their equitable access to resources such as land and credit. Moreover, despite their predominant role in production systems in the mountains, there is little understanding and appreciation of their contributions to the community, and gender relations in the mountain regions remain unbalanced. In order to challenge this current trend. mountain women's voices need to be



heard

and incorporated into the various policies and programmes. New development approaches based on respecting the rights and needs of all peoples need to be initiated.

The United Nations, as a leading development agency, has declared 2002 as the International Year of Mountains (IYM) with the Food and Agriculture Organization (FAO) as the lead agency. This provides us with a unique opportunity to address

mountain people and highlight their realities in the international forum. Most importantly, it will give mountain women a chance to voice their concerns on different issues, develop their ideas and promote their interests. In this context, a Steering Committee\* was established to put mountain women on the agenda and to organise a global conference with the help of ICIMOD and the Mountain Forum. To do this, a Secretariat was established at ICIMOD, 'Celebrating Mountain Women' (CMW), to launch a long-term programme for mountain women starting with the international conference. This conference is a chance to celebrate the drive, spirit and diversity of mountain women everywhere. The Food and Agriculture Organization (FAO) and International Fund for Agricultural Development (IFAD) funded the Planning Meeting, which was held in May 2001 in Kathmandu, Financial support for the conference has also been committed by IFAD, the Japanese Government Overseas Development Agency (ODA), and the United Nations Development Fund for Women, South Asia (UNIFEM, ROSA). However, although preparations advanced, further support will be needed if the conference is indeed to become a reality.

#### Press Release, "Kathmandu, May 11 - 2001

Twenty women from Africa, Asia, Europe, Latin and North America concluded a three-day meeting during which they finalised a plan of action for a mountain women's agenda.

The meeting proposed an international gathering in May 2002 to be held in Kathmandu, bringing together almost 300 participants, including mountain women, NGOs, mountain entrepreneurs, re-searchers, parliamentarians, senior government officials, funding agencies and media representatives.

Participants from about 70 countries representing the world's major mountain ranges, especially the marginalised communities, are expected to attend the meeting. The focus of the meeting will be to show the strength and commitment of mountain women in making a positive contribution to local and national economies. Towards this, discussions, activities, and events will highlight and showcase practical aspects of mountain life - their stories, songs, dances, foods, crafts, textiles, traditional knowledge, and efforts to make constructive change.

The meeting will also address the issues of concern such as legal and political rights, health and well-being, conservation of traditional wisdom and natural resources, women's labour, and opportunities for entrepreneurship.

The International Centre for Integrated Mountain Development and the Mountain Forum are organising the May 2002 event, planned as part of the UN declared International Year of Mountains. The decision to hold this event was made at a meeting of the Mountain Forum Council in Cusco, Peru, in 2000.

As a forerunner for the May meeting, a curtain raiser is being planned on March 8, International Women's Day.

The conference will try to facilitate much-needed face-to-face interactions by bringing together indigenous women, donor agencies, policy makers and planners, entrepreneurs, and researchers to share the problems and progress of mountain women. It will provide a new beginning through interaction. participation. expression. It will give mountain women a forum through which to articulate their concerns and share experiences and ideas about the future of mountain livelihoods and cultures. Such a gathering will enable the mountain women's networks to not only grow and strengthen as agents of change, but also to make a significant contribution to policies and practices that empower mountain women and their communities.

The first-of-its-kind global celebration of mountain women will focus on empowerment through innovation and entrepreneurship. It is unique in that it will facilitate face-to-face interaction of various actors in the development sectors that do not normally come together. The activities planned will put mountain women centre stage, mainstream their reality into the IYM discussions and Rio+10, and enable a major paradigm shift.

During the planning meeting of CMW, which was held in Kathmandu from May 8-10, 2001 (see press release), the organising committee elected women representing various parts of the world to form the Steering Committee (SC). These members will have an instrumental role in planning and organising the upcoming events. They will advise, guide, support, assist, and inform the Secretariat staff throughout the year. In addition, the SC members will organise regional meetings in their respective regions.

During the planning meeting the committee also proposed five theme areas around which activities will be planned. These theme areas include Natural Resources; and Environment; Health and Well Being; Entrepreneurship; Legal, Political and Human Rights; and Culture and Indigenous Knowledge. These themes will be highlighted in the framework of research, policy, and practices through various presentations, songs, stories, theatre, videos, and so on.

A strategic media plan is being developed to increase and improve public awareness through coverage of mountain women's issues and of the events being planned; it will include electronic networking and e-

conferences. A series of specific preparatory activities will ensure appropriate dissemination coverage of the event: viz. identifying mountain women's groups and networks; documenting mountain women's initiatives. organising regional meetings between mountain women and policy-makers, building interactive databases, and locating mountain women's cultural resources such as songs, crafts, films, videos, and stories. Throughout the conference, a bazaar of mountain women's products will be held. Stalls will be available for those wishing to participate.

It is envisioned that a gathering on an international scale like this one will help change the prevailing perceptions of mountain women. It will help create new coalitions, networks, and partnerships of women to influence policies and encourage mountain women and others to celebrate their champions, and give voice to their issues related to the future of mountain livelihoods and cultures. Finally, the role of women as agents of change and peacemakers in conflict in mountain areas will gain significance.





# Launching of the Nepal SoE Report

On 26 March, the report 'Nepal: State of the Environment 2001' was launched by Dr. Klaus Töpfer, United Nations Under Secretary General and the Executive Director of UNEP - United Nations Environment Programme - in front of over 200 dignitaries, representing government, non-government and international agencies and universities, at the Soaltee Hotel.

The State of the Environment (SoE) report for Nepal, prepared under the SEAMCAP project - Strengthening Environmental Assessment and Monitoring Capabilities in South Asia and the Greater Mekong Subregion - was produced jointly by the Ministry of Population and Environment, the United Nations Environment Programme/ Environmental Assessment Programme for Asia and the Pacific, SACEP - South Asia Cooperative Environment Programme, and ICIMOD. This report, prepared in coordination with government, non-government, and private sectors working in different environmental fields, is one of nine national reports for the SEAMCAP regional countries: Bangladesh, Bhutan, India, Maldives, Nepal, Pakistan, and Sri Lanka in South Asia and Laos and Vietnam in the Greater Mekong Subregion. The report will contribute to the 'Preparation' of the Global State of the Environment Report 2002', which Dr. Töpfer with 'Nepal: State of the Environment 2001' UNEP is mandated to produce.



Dr. Töpfer was very impressed by the work being conducted through the SEAMCAP and MALE project and announced that UNEP will be opening an office in Kathmandu in 2001 to coordinate air pollution research.

# The Third Quinquennial Review

Despite the sad events that gripped Nepal on June 1st 2001 and in the aftermath, ICIMOD's Quinquennial Review went ahead. The centre has reason to be grateful to its reviewers for undertaking their task in difficult circumstances but with a commitment and thoroughness of which both they and the Centre can be proud.

The members of the review team were Dr.Mohan Man Sainju (Team Leader), Dr.Uwe Kievelitz (Report Coordinator), Professor Li Wenhua (Member) Mr. Ivar Jorgensen (Member) and Ms. Bharti Gupta Ramola (Member). Coming from different nations and different disciplines, the team concluded a comprehensive evaluation over the course of a month which included field visits in the HKH region.

In brief, the team found that ICIMOD had achieved significant impact in a number of areas. Most importantly it had "infused a mountain perspective into the work of many of its more than 200 partner organisations in the region and by capacity building of 6,000 participants in 280 training workshops and programmes". The team mentioned specific highlights of the different areas of work at ICIMOD as commendable achievements, at the same time pointing out the structural weaknesses that remain. The Centre was urged to pay direct attention to programme monitoring and evaluation to ensure an impact in its two key areas, poverty alleviation in mountain areas and conservation of natural resources. Increased integration of programmes was strongly recommended.

The review team acknowledged the role of ICIMOD in preparing and disseminating mountain-specific knowledge in a policy relevant manner, its advisory capacity, and promoting the use of knowledge gathered in its member countries.

Other recommendations include establishment of a Trust Fund, strategic focus of thematic and regional priorities, a sound PME system, strategic networking and partnerships, and an 'innovative, electronically-based, knowledge-sharing network that can push the region into the 21st century.' Finally, the QQR recommended aligning internal structures to priorities through an organisational development process.

To quote Charles Dickens, "It was the best of times and it was the worst of times." In times to come, the Centre will be able to look back on receiving a fair and insightful evaluation of its work and guidance for the future during the worst of times for its host nation.

Many thanks to the review team who lived through it with us and worked with sincere and industrious commitment. This Review will be presented to the Board of Governors and ICIMOD Support Group for their consideration at the forthcoming meetings in Thimpu, Bhutan in the first week of December.

#### Flood Forecasting in the Hindu Kush - Himalayan Region

A major regional initiative

Organised by ICIMOD in conjunction with the World Meteorological Organization (WMO) and cohosted by the Department of Hydrology and Meteorology of His Majesty's Government of Nepal, this meeting was sponsored by the US State Department's Environment Diplomacy Fund, US Office for Foreign Disaster Assistance (OFDA), and Danish International Development Assistance (DANIDA). There were 58 participants from Bangladesh, Bhutan, China, India, Nepal, and Pakistan, as well as international experts on floods and flood forecasting at the meeting. On May 15, all took part in a field excursion to Kodari (Nepal-China Border) to witness the impact of floods on the ground.

#### Flood Forecasting: Headline News

Press Report The Kathmandu Post (May 16, 2001)

With a vision that timely forecasting of floods can save lives and property, experts from the Hindu-Kush Himalayan region and various international organisations have converged here for a consultative meeting on developing a framework for flood forecasting in the region.

Minister for Science and Technology Surendra Prasad Chaudhary on Wednesday opened the four-day meeting attended by experts from Bangladesh, Bhutan, China, India, Nepal and Pakistan. The meeting is jointly organised by the International Centre for Integrated Mountain Development (ICIMOD), and the World Meteorological Organisation (WMO), and supported by HMG's Department of Hydrology and Meteorology (DHM).

"The 1993 flood disaster in Nepal claimed more than 1,300 lives and caused enormous damage to property and infrastructure," Chaudhary said. "It has taught us a painful lesson on why timely flood warning systems should also be in place on some of the major rivers in order to save lives and property and avoid disasters." Dr Adarsha Pokharel, Director General of the DHM, spoke of the urgent need to carry out extensive research for enhanced data acquisition and management, analysis, and plausible interpretations of hydro-meteorological data on the basis of which flood forecasting is done.ICIMOD Director General Dr J Gabriel Campbell, New Delhi-based UNESCO Director MS Alam, and other experts also emphasized the need for an effective flood forecasting mechanism in the region.

Flash floods and landslides routinely leave trails of destruction in the region every year. In Nepal, floods and landslides are considered as the second biggest killer after epidemics, with the average annual toll standing at 350. Between 1983 and 2000, at least 2,300 livestock and more than 6,700 houses and 4,760 hectares of arable lands have been damaged by landslides and avalanches, according to data made available by the Home Ministry.

#### 1. HKH-FRIEND/ICSI Workshop on Snow and Glacier Mass Balance Manual Development

A Workshop on Snow and Glacier Mass Balance Manual Development was organised by the Snow and Glacier Group of HKH-FRIEND in collaboration with the International Commission on Snow and Ice (ICSI) from 20-24 March 2001 at the International Centre for Integrated Mountain Development (ICIMOD), Kathmandu, Nepal. Financial support for this workshop was received from UNESCO/IHP, and ICIMOD. The major objectives of the workshop were to finalise the table of contents of the manual for training on Snow and Glacier Mass Balance Measurements/Studies in the HKH region and to assign responsibilities to the participants to prepare the manual. It was attended by 21 participants from Austria, Canada, China, India, Japan, Nepal, USA, UNESCO, and ICIMOD and included experts from ICSI and the HKH-FRIEND Snow and Glacier Group. The participants included Prof. H.G. Jones, President-Elect, and Dr. G. Kaser, Secretary of ICSI. Mr. A.P. Pokhrel, Director General, Department of Hydrology and Meteorology of HMG-Nepal is the Coordinator of the Snow and Glacier Group of HKH-FRIEND. The workshop programme included a field visit to the headwater regions of snowfed rivers of Nepal, and included one at Kodari, on the Border of Nepal and the Tibet Autonomous Region of China.

The Workshop provided a good opportunity to the participants from the region and outside to review modern and conventional methods of glacier mass balance measurement and decide on a future course of action for identifying glaciers for monitoring mass balance measurements in the HKH region, preparing a training manual, and organising training, all according to standards set at the meeting.

The Department of Science and Technology, Government of India (funding agency for the Indian Glaciology Programme), has assured the School of Environmental Sciences, Jawahar Lal Nehru University, New Delhi, of funds for the proposed ICSI training programme in October 2002.

#### 2. HKH-FRIEND Surface/River Water Quality Training Workshop

A Training Workshop on HKH-FRIEND Surface/River Water Quality was held in Islamabad, Pakistan, from May 21 to 26, 2001. The training was organised by the Pakistan Council of Research in Water Resources (PCRWR) on behalf of HKH-FRIEND/River Water Quality Group. Prof. Dr. M. F. Bari, BUET, Bangladesh, the group coordinator of the HKH-FRIEND/River Water Quality group is coordinating this. Financial support for the training was received from UNESCO/IHP, New Delhi, and the German IHP/OHP National Committee-Federal Institute of Hydrology, Koblenz, Germany. The participants were from Bangladesh, India, Germany, Nepal, and Pakistan.

#### **National Workshop on Wind Energy**

A two-day National Workshop on Wind Energy was organised by the Ministry of Science and Technology, ICIMOD, and ITDG Nepal on the 7th and 8th of March 2001 with the twin objectives of sharing the Sri Lankan experience of 200-watt, small windmills developed by ITDG and developing a national course of action for the development of wind energy in Nepal.

A 6-member task force (including the Renewable Energy Specialist, ICMOD ) was formed to set priorities and bring into effect the recommendations prepared by the participants. The task force made the following recommendations.

- Publish proceedings of the workshop
- Select sites and run pilot projects on small-scale wind energy plus wind pumping
- Conduct wind mapping in most potential areas
- Prepare guidelines for private sector participation in wind energy development
- Develop a methodology for data generation and analysis
- Document Nepalese experience and experiences of Bihar/Gujarat in India on wind pumping and of Mongolia on wind energy through field visits by a team
- Conduct a National Workshop on Wind Energy in 2002 to discuss the experiences from 2001 and plan further
- Form a Coordination Committee under the Ministry of Science and Technology to facilitate coordination and follow up on planned activities

# NEW VIDEO Warning Signals from the Apple Valleys

A film by Uma Partap

This video, shot in apple valleys in Himachal Pradesh (India), the Northern Areas and Balochistan Province of Pakistan, and Maoxian county of China, highlights the pollination problems faced by apple farmers (and farmers of other crops) in the Hindu Kush-Himalayan region. The importance of apples in the economy of mountain areas is shown, together with the problem of declining apple productivity due to inadequate pollination. Excellent shots illustrate the major causes: insufficient pollinisers (trees), lack of pollinating insects, and bad weather conditions (climate change). The film shows how some farmers manage apple pollination -large-scale use of polliniser bouquets to increase the proportion of pollinisers and use of honeybees as pollinating insects in Himachal Pradesh, India, and hand pollination in Maoxian county China.

#### ICIMOD Mission to the IFAD Project in North East India

Four ICIMOD staff, Dr. T. S. Papola, Dr. Kamal Rijal, Dr. Pradeep Tulachan, and Ms.Atsuko Toda visited Assam and Meghalaya from 9-23 February 2001 on a Fact Finding Mission to provide implementation support to IFAD's 'North East Region Community Resource Management Project (NERCRMP)'. The team travelled to villages in four districts in Assam and Meghalaya and detailed discussions and interaction with villagers and project officials in the field as well as at the project headquarters and at relevant institutions and agencies in the region led to identifying several activities for collaborative implementation. These activities include action-oriented diagnostic studies, exchange visits, action research, feasibility studies, documentation of best practices, training, consultation, and advisory services in the areas of farm production and productivity with a focus on improving shifting cultivation practices, enterprise development and marketing, renewable energy and rural technologies, GIS, risk engineering, and development communications. Follow-up on the mission's recommendations has already been initiated with a visit of the Project Management Team to ICIMOD and some project sites in Nepal during March 2001.

#### **ICIMOD's Beekeeping Programme in Jumla**

The project continued with its efforts to raise awareness about the importance of conserving indigenous honeybees and biodiversity among beekeepers, farmers' organisations, GOs, and NGOs.

- Two farmer-led NGOs and 67 beekeepers' groups were formed through project facilitation and support - these groups and organisations are now involved in beekeeping research and development.
- A functional beeswax collection and processing centre in Jumla bazaar managed by 4S, an organisation linked to beekeepers' groups, was promoted.
- A number of women farmers have been trained in beekeeping and are participating in various training programmes, meetings, and community development activities.



As demand for honey grows, the number of hives increases

- One hundred and forty-three local farmers-trainers were trained in beekeeping management and conservation and are playing a very important role in capacity building of local beekeepers.
- The Project facilitated provision of various types of appropriate technologies with full participation of real beneficiaries. One
  of the successful appropriate technologies considered was the Jumla Top Bar Hive. Farmers were trained in the skills needed
  for sustainable beekeeping management.
- Awareness was raised about the importance of pollination through beekeeping.
- Farmers are trained on honey harvesting and processing, and producing value-added products like creams and candles.
   Production of processed and good quality honey is increasing, as is the demand for pure organic honey
- Farmers have access to information related to beekeeping and there are organisations working together for better linkages.
- There are three selection and multiplication apiaries; farmers are managing the selection and multiplication programme.

#### Mountain Orientation of Enterprise Development Policies - National Consultation in Nepal

ICIMOD collaborated with the Industrial Enterprise Development Institute (IEDI), Kathmandu, to organise a consultation meeting of policy-makers, industry representatives, and NGOs and INGOs involved in enterprise development to assess the adequacy and suitability of present policies for promotion of micro, small, and medium enterprises in mountain areas. The consultation meeting, held from 11-12 April 2001, was attended by about 30 persons. A paper describing and reviewing the existing policies and programmes, identifying gaps, and recommending policy changes, prepared by IEDI, provided the background for discussion. The meeting identified several product lines with a comparative advantage in mountain areas and the policy support required to promote enterprises in them. It was agreed that IEDI will pursue implementation of recommendations arrived at during the meeting with policy-making bodies.

#### Himalaya Field Study Programme, Nepal 2001

Extracts from a report by Mohan Prabhu QC, Executive Director Canada-Commonwealth Human Ecology Council

Fourteen Canadian university students and five professionals took part in a three-week Himalaya Field Study Programme (HFSP) in Nepal, from 1-22 May, 2001. The two leaders of the programme were Mohan Prabhu QC, Executive Director of Canada-CHEC, and Dr. Sharad Karmacharya. HFSP was carried out by Canada-CHEC in pursuance of its mandate to create awareness of environmental issues in developing countries among Canadians and at the same time promote education. It was the second programme of its kind conducted by Canada-CHEC - the first was held six years earlier in 1994 in Ladakh, India.

Topics were discussed in workshops and at round tables, with experts from ICIMOD, Nepal Government (Planning Commisstion, National Parks and Wildlife Management, Nepal Tourism Board), King Mahendra Trust for Nature Conservation, FAO, World Wildlife Fund, South Asia Partnership (SAP)-Nepal, and others. The chairperson of a regional women's organization gave a presentation on women's participation in decision-making, and the Head of the Canadian Cooperation Office made a presentation on CIDA'S programme in Nepal. Field visits included a three-day stay in the Royal Chitwan National Park. The final two days were devoted to a round table discussion by students on what they had learned about ecology issues in Nepal.


#### **Book Fair at ICIMOD**



Natural grasslands cover approximately 14 per cent of Nepal

and are important areas in terms of biodiversity and sources of forage for wild ungulates and domestic livestock. In the plains (the Terai), natural grasslands occur along flood plains and terraces, but now only exist in their natural state within protected areas (PAs). At higher altitudes, trans-Himalayan and alpine rangelands are home to a diverse array of wildlife and are grazed by livestock.

A workshop on Grassland Ecology and Management in Protected Areas of Nepal was organised jointly by HMG/N's Department of National Parks and Wildlife Conservation (DNPWC), the International Centre for Integrated Mountain Development (ICIMOD), and WWF Nepal Programme, from March 15-19, 1999, at Royal Bardia National Park, Nepal. The goal of the workshop was to summarise the major grassland ecological research work conducted to date and devise effective research and management strategies for grasslands in PAs in the mountain and Terai areas of Nepal.

The proceedings from the workshop are divided into three volumes. Volume I is the Workshop Action Summary and contains a brief summary of the papers presented in Volumes II and III, as well as a summary and synthesis of the workshop findings and recommendations; Volume II presents the status and research papers from the Terai protected areas of Nepal and India; and Volume III presents the status and research papers from protected areas in the mountains.

This report has been prepared based on the best data available, but in many cases there were clear limitations and gaps. The authors have done their best to ensure that, within the constraints, an accurate enough idea of the state of the environment in Nepal has been obtained.

Disaster mitigation requires better understanding of the physical nature of the region and the impact of human activity, with integration of knowledge from such diverse fields as geology, geophysics, engineering, hydrology, and meteorology, to facilitate more effective planning and implementation of activities.
